The Bank of America CEO of the Year Award recognizes the importance of executive leadership in an organization's achievement of mission-related results. An award of \$5,000 will be presented to the winner and \$1,000 each will be awarded to two finalists at the Center for Nonprofit Management's Salute to Excellence Awards.

Requirements of the Bank of America CEO of the Year Award:

- Must be an organization that has been a 501(c)(3) for at least three years and is a member of CNM.
- Local chapters of national organizations may apply, provided the chapters are locally managed and have financial information available on a local basis.
- Previous winners of this award are not eligible to reapply for three years.
(For example, if the agency was a winner in 2014, the agency is eligible to re-apply in 2018.)
- Previous finalists for this award may reapply, but not for this award for one year.
(For example, if the agency was a finalist in 2016, the agency is eligible to re-apply for this award in 2018.)
